The 1st quarter of 2025 Financial Report, prepared on April 20, 2025, and the 1st quarter of 2024 Financial Report show a discrepancy of 10%. The company would like to explain as follows:

The after-tax profit for the 1st quarter of 2025 is 84,726,891,606 VND, an increase of 39% compared to the same period last year.

Due to the following reasons:

- Revenue in the 1st quarter of 2025 decreased by 0.4% compared to the 1st quarter of 2024 due to an 8% drop in consumption volume; however, the selling price of yellow phosphorus products increased by 8% compared to the same period last year. Notably, financial costs decreased by 36%, and selling expenses decreased by 10%. As a result, the company's after-tax profit increased by 39% compared to the same period last year.
